My office is general counsel for the Conscious Co-Parenting Institute (“CCPI”). I have been made aware of an ongoing Oregon licensing board complaint procedure concerning Dr. Craig Childress.

To Whom It May Concern,

This letter is written in support of Dr. Craig Childress in response to the Oregon licensing board complaint filed against him.

The client referenced for Dr. Childress is a client of ours, the Custody Resolution Method (CRM), and the Conscious Co-Parenting Institute. Dr. Childress serves as a consultant in clinical psychology to the CRM, and it was in this capacity that he wrote a consultant's report for the Custody Resolution Method referenced in the board complaint.

The client, xxxxx, is a client of Conscious Co-Parenting Institute, and he hired us to tag the data he provided through the CRM program, and the consultant report produced was for CRM. The Custody Resolution Method (CRM) is a data tagging procedure to compile frequency counts for categories of interest from large documented data sets. Clients of CRM submit documents (emails, reports, text messages, etc.) to CRM for data tagging. We hire and train data taggers to read the data set and tag pre-determined categories of data located in the data set.

Once a frequency count for the various categories is obtained, this data profile is submitted by CRM to Dr. Childress for an opinion on the data profile. Dr. Childress never has contact with the client of CRM, and Dr. Childress is paid directly by CRM for each consultant's report. The report produced for the Custody Resolution Method referenced in the board complaint is for a client of the Custody Resolution Method, and Dr. Childress had no direct contact with our client.

The scope of work provided by Dr. Childress for CRM is to review the compiled data profile produced by the data-tagging procedures employed by the Custody Resolution Method and to provide his opinion on the compiled data profile. Dr. Childress has no contact with our clients with regards to the report he wrote for the Custody Resolution Method, his opinions are based on the tagged data profiles provided to him, and he is paid for his services through the Custody Resolution Method.
