Dr. Drozd Vita Analysis (Standard 2.01 Competence)

Summary of Dr. Drozd's education, training, and experience regarding competence in:

- 1) the diagnostic assessment and treatment of attachment pathology in children,
- 2) the diagnostic assessment of delusional thought disorder pathology,
- 3) the diagnostic assessment and treatment of factitious disorders imposed on children,
- 4) the diagnostic assessment and treatment of child abuse and complex trauma,
- 5) the diagnostic assessment and treatment of personality disorder pathology (narcissistic-borderline-dark), and
- 6) the diagnostic assessment and treatment of family systems pathology:

That is essentially the entirety of Dr. Drozd's education, training, and experience relative to professional competence.

Analysis: Dr. Drozd has the least amount of education and experience possible and still be a psychologist.

Competence:

- **Attachment Pathology:** based on her listed education, training, and experience, Dr. Drozd is not competent in the diagnostic assessment and treatment of attachment pathology in children.
- **Delusional Thought Disorders:** based on her listed education, training, and experience, Dr. Drozd is not competent in the diagnostic assessment and treatment of delusional thought disorders .Dr. Drozd is not competent in the diagnostic assessment and treatment of child abuse and complex trauma based on her education, training, and experience.
- **Personality Disorder Pathology:** based on her listed education, training, and experience, Dr. Drozd is not competent in the diagnostic assessment of personality disorder pathology.
- **Child Abuse & Complex Trauma:** based on her listed education, training, and experience, Dr. Drozd is not competent in the diagnostic assessment of child abuse and complex trauma.

- **Family Systems Pathology:** based on her listed education, training, and experience, Dr. Drozd is not competent in the diagnostic assessment and treatment of family systems pathology.

Summary:

Dr. Drozd obtained her bachelor's degree 50 years ago in Political Science and History, and she became a school teacher for a decade (teaching certificate). In the 1980s she went back to school (a professional school) for a doctorate in Clinical Psychology.

The only documented education in psychology that Dr. Drozd has received was 40 years ago in her doctoral program.

Upon graduation with a Ph.D., Dr. Drozd entered private practice in the family courts. That is her only substantive work experience listed.

Dr. Drozd has had limited and highly restricted work experience – one position (private practice) is highly insular - her clients are court-ordered – one role (conducting forensic custody evaluations).

One degree presented in two parts for her vita (trying to expand the appearance of her training). Some professional schools (CSPP) give a Master's degree halfway through to allow their students to get licensed as an MFT to earn money and gain experience during the last two years of the doctoral program.

Attended CSPP for her Master's degree in 1984. Became licensed as an MFT, then continued in CSPP, San Diego for her doctorate. This is essentially just one doctoral degree from CSPP San Diego split into two parts for reporting on her vita, with an MA at the mid-point (allowing licensure and work), culminating in a Ph.D. at the endpoint.

Note for contrast, Dr. Childress entered Pepperdine University with a separate Master's degree in Clinical-Community psychology from Cal State University, Northridge. That's two degrees from two separate institutions. If a Master's degree is acquired during a single doctoral program (i.e., at the midpoint), only the doctoral program is relevant for education received.

Is Dr. Drozd trying to expand the appearance of her prior education and training?

She obtained a teaching credential from UCLA in 1971 (after graduating with a bachelor's degree in Political Science and History. She worked as a teacher for ten years before entering CSPP in 1982, a professional school in psychology, in a career change to become a psychologist.

- Dr. Drozd seemingly became dissatisfied with her life in teaching and decided to return to graduate school to become a psychologist. She chose a local-area professional school to obtain her doctorate in psychology. In the progress to her four-year doctoral degree, she became a licensed MFT.

Bachelor's Degree in Political Science and History, with Honors, University of California, Santa Barbara, 1970.

BA in Political Science and History, not Psychology, from UC Santa Barbara. Then she got a teaching credential and taught for ten years. Then she career-changed to become a psychologist. Dr. Drozd's education in psychology is minimal.

Her only psychology education was from the program at CSPP 40 years ago. Prior to that she was a schoolteacher for ten years.

Clinical Job History

Only one private practice "clinical" job. Dr. Drozd again appears to be splitting one vita entry (private practice) into two (one entry for the doctorate and one for the Master's degree) for essentially the same work experience.

That is the extent of Dr. Drozd's substantive education, training, and experience in psychology. This represents is an exceedingly thin vita – it would be difficult to become less substantial.

Education

Her only education in professional psychology is from the CSPP doctoral program (her BA is in Political Science and History, and she has a teaching credential). This is minimal education. For comparison, the BA of Dr. Childress is in Psychology from UCLA, with a separate Master's degree in Community/Clinical psychology from Cal State, Northridge, and a Psy.D. from Pepperdine University in Clinical Psychology – that's three programs supplemented by additional training.

Source of Clinical Training

Her classroom education was in her doctoral program. Where did Dr. Drozd obtain her clinical training (i.e., the diagnostic assessment and treatment of pathology; specifically, child and family pathology)?

- **Attachment Pathology:** where did she obtain her education, training, and experience (competence) in the diagnostic assessment and treatment of attachment pathology in children?
- **Delusional Thought Disorders:** where did she obtain her education, training, and experience (competence) in the diagnostic assessment of delusional thought disorders?

The only clinical experience Dr. Drozd has identified is her solo private practice. There has seemingly been no additional training in any form of child or adult pathology since her doctoral degree 40 years ago.

After obtaining her doctorate, from that point on she has been doing solo private practice in the family courtss. She has minimal psychology education, and she seemingly has minimal clinical experience (beyond her solo private practice in the family courts conducting forensic custody evaluations).

Forensic Job History

She seemingly does one thing: forensic custody evaluations.

She has no breath of training or experience in child and family therapy or with any child pathology. She meets with family members several times and then renders an opinion on

what the custody schedule should be. Forensic custody evaluations do not diagnose the pathology (identify the cause of the problem) at a professional level (DSM-5).

- **An Experiment on Human Subjects:** forensic custody evaluations are an experiment on human subjects in a “quasi-judicial” role for doctors of advising the court on custody rather than diagnosing and treating pathology (the standard healthcare role of doctors). Dr. Drozd conducts the experimental assessment procedure on human subjects in the family courts, called a forensic custody evaluation, that was developed for the experimental quasi-judicial role for doctors.

She has no breadth of experience.
